ANNEX 1

Below is an extract of information provided by the IFRA in relation to types of application present in each IFRA Category. Additional information about IFRA Categories can be found in the Guidance to IFRA Standards, issued by the IFRA.

IFRA CATEGORY	PRODUCT TYPE
Category 1	Lip Products of all types (solid & liquid lipsticks, balms, clear or coloured etc.); Children's Toys
Category 2	Deodorant & antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne, etc.). Body sprays (including body mist)
Category 3	Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.); including eye care & moisturizer; Facial make-up & foundation; Make-up remover for face & eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands, body; Body & face paint (for children & adults); Facial masks for face & around the eyes.
Category 4	Hydroalcoholic & non hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragancing cream, etc), aftershaves of all types (except creams & balms); Fragranced bracelets; Ingredients of perfume kits & fragrance mixtures for cosmetic kits; Scent pads, foil packs; Scent strips for hydroalcoholic products.
Category 5A	Body creams, oils, lotions of all types; Foot care products (creams & powders); Insect repellent (intended to be applied to the skin); All powders & talc (excluding baby powders & talc).
Category 5B	Facial toner; Facial moisturizers & creams (including care products for beard & mustache).
Category 5C	Hand cream; Nail care products including cuticle creams, nail lacquer remover, etc.; Hand sanitizers.
Category 5D	Baby cream / lotion, baby oil, baby powders & talc.
Category 6	Toothpaste; Mouthwash, including breath sprays; Toothpowder, strips, mouthwash tablets.
Category 7A	Hair permanent or other hair chemical treatments (rinse-off) (e.g., relaxers), including rinse-off hair dyes.
Category 7B	Hair sprays of all types (pumps, aerosol sprays, etc.); Hair styling aids non-sprays (mousse, gels, leave-on conditioners); Hair permanent or other hair chemical treatments (leave-on) e.g., relaxers), including leave-on hair dyes; Shampoo – Dry (waterless shampoo); Hair deodorizer, hair perfume.
Category 8	Intimate wipes; Intimate deodorant spray; Tampons; Baby wipes; Toilet paper (wet).
Category 9	Bar soap; Shampoo of all types; Cleanser for face (rinse-off); Conditioner (rinse-off); Liquid soap; Body washes & shower gels of all types; Baby wash, bath, shampoo; Bath gels, foams, mousses, salts, oils & other products added to bathwater (such as bath bombs); Foot care products (feet are placed in a bath for soaking); Shaving creams of all types (sticks, gels, foams, etc.); All depilatories (including facial) & waxes for mechanical hair removal.
Category 10A	Hand wash laundry detergent (including concentrates); Laundry pre-treatment of all types (e.g., paste, sprays, sticks); Hand dishwashing detergent (including concentrates); Hard surface cleaners of all types (bathroom & kitchen cleansers, furniture polish, etc.); Machine laundry detergents with skin contact (e.g. liquids, powders) including concentrates; Toilet seat wipes; Fabric softeners of all types excluding fabric softener sheets; Household cleaning products, other types including fabric cleaners, soft surface cleaners, carpet cleaners, furniture polishes sprays & wipes, leather cleaning wipes, stain removers, fabric enhancing sprays, treatment products for textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics); Floor wax; fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners (non-cartridge systems), etc., Ironing water (Odorized distilled water); Dry cleaning kits (involving manual application on the textile).
Category 10B	Animal sprays – sprays applied to animals of all types; Air freshener sprays, manual, including aerosol & pump; Aerosol / spray insecticides.
Category 11A	Féminine hygiène conventional pads, liners, interlabial pads ; Baby diapers ; Incontinence pant, pad ; Toilet paper (dry).
Category 11B	Tights with moisturizers; Scented socks, gloves; Facial tissues (dry tissues); Napkins; Pillow spray; Paper towels; Wheat bags; Facial masks (paper / protective) e.g., surgical masks not used as medical device; Fertilizers, solid (pellet or powder).
Category 12	Candles of all types (including encased); Laundry detergents for machine wash with minimal skin contact (e.g., Liquid tabs, pods); Automated air fresheners & fragancing of all types (concentrated aerosol with metered doses (range 0.05-0.5ml / spray), plug-ins, closed systems, solid substrate, membrane delivery, electrical, powders, fragancing sachets, incense, liquid refills (cartridge), air freshening crystals, solid non-aerosol car diffuser); Air delivery systems; Cat litter; Cell phone cases; Deodorizers / maskers not intended for skin contact (e.g., fabric drying machine deodorizers, carpet powders); Dry cleaning kits (placed in the dryer); Dryer sheets & fabric softener sheets; Fuels; Insecticides (e.g., mosquito coil, paper, electrical, for clothing) excluding aerosols / sprays; Joss sticks or incense sticks; Dishwash detergent & deodorizers – for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch & sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes, Rim blocks (toilet); Toilet gel; Scent beads.
